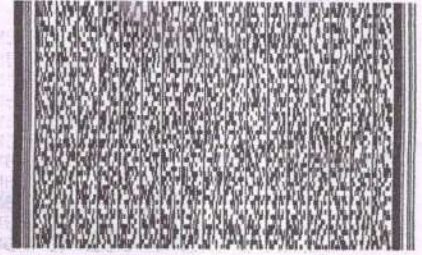

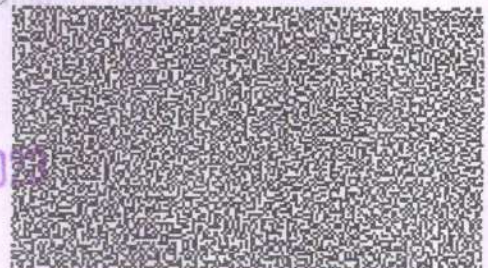



APPENDIX-IV
